

#### Introduction

Since the period of military dictatorial regimes, the Republic of Korea has carried out the policy of putting its national security foremost, and the divided situation of the Korean Peninsula has continued the practice of regarding the duty of military service as sacred. Therefore, human rights issues related to the military have been out of people's interest until the most recent, and the cases of objection to military service based on religious teachings and conscience in Korea or in foreign countries have scarcely known to the public.

Under these circumstances, the Korean government has never reported the situation of conscientious objection in Korea to the UN in disregard of its obligation as a member of UN and as a party to the International Covenant on Civil and Political Rights (hereinafter referred to as the ICCPR), under which it shall respect UN's relevant resolutions and regularly report its domestic human rights conditions to the UN. Also, because Korean civic groups have not understood conscientious objection as one of human rights issues due to such a unique situation of Korea, they have been unable to urge the Korean government to perform its obligations under UN's resolutions and the ICCPR concerning conscientious objection.

In the beginning of 2001, however, the fact that lots of conscientious objectors had been criminally punished before and many people are currently being imprisoned, mostly sentenced to three-year imprisonment, began to be known to the public giving quite a shock. Thereafter, conscientious objection became one of the serious human rights issues of the minorities in Korea. Although the Constitution of the Republic of Korea provides that the freedom of religion and conscience should be guaranteed by the State as one of the fundamental human rights for individuals to realize human dignity and value and to pursue happiness, conscientious objectors in Korea have not been able to enjoy the freedoms of religion and conscience.

Because there is no alternative service system in Korea provided for conscientious objectors who are willing to do social services instead of military service, conscientious objectors are to be severely punished, without exception, according to the Military Service Act and the Military Penal Code. Thus if the present laws and regulations for punishing them are not improved, conscientious objectors are subjected to imprisonment and have to suffer disadvantages and discriminations which are irrecoverable in the society. This situation in Korea, where there exist only punishment regulations and no alternative service system for conscientious objectors, is clearly against the relevant resolutions and recommendation of the Commission on Human Rights and the Human Rights Committee that recognize conscientious objection as

one of important human rights guaranteed by the ICCPR. Therefore, the Korean government must take an immediate action to improve its present system related to conscientious objection.

We hereby state the action that the Korean government must take for conscientious objection, after looking into relevant resolutions of the UN, which has upheld conscientious objection as a civil right, and introducing the present situation of conscientious objection in Korea.



# Relevant resolutions of the United Nations and Responsibility of the Korean Government

#### A. PRIMARY RESOLUTIONS OF THE UN CONCERNING CONSCIENTIOUS OBJECTION

#### (1) Commission on Human Rights

....

The Commission on Human Rights of the United Nations (hereinafter referred to as the Commission) in its resolution 1987/46(E/CN/1987/60) declared for the first time that conscientious objection to military service is one of the human rights to which States should give respect. In this resolution, the Commission urged each State to recognize that conscientious objection derives from principles and reasons of conscience, including profound convictions, arising from religious, moral, ethical, humanitarian or similar motives. Then in 1989, another resolution was adopted (E/CN.4/1989/59, Preamble, para. 1) in which the Commission emphasized that, according to Article 3 and 18 of the Universal Declaration of Human rights and Article 18 of the ICCPR, each State recognizes conscientious objection as a human right stipulated in the Charter of the United Nations and the ICCPR.

In 1993, the Commission adopted the resolution 1993/84(E/CN.4/122) reaffirming its attitude of the previous resolutions on the subject. In the resolution, it requested States to establish "independent and impartial decision-making bodies" in their domestic legal system, with the task of determining whether a conscientious objection is genuinely held in a specific case. The Commission, reflecting the General Comment No.22 of the Human Rights Committee on the interpretation of Article 18 of the ICCPR, passed a resolution in 1995 that States shall not discriminate against conscientious objectors on the basis of the nature of their particular beliefs, and shall

not punish them for the failure of performing military service.

On April 22, 1988, the Commission passed a resolution (E/CN.4/1988/77), which is called as the Magna Charta of conscientious objection. The primary contents of this resolution are as follows:

- (a) Conscientious objection to military service derives from principles and reasons of conscience, including profound convictions, arising from religious, moral, ethical, humanitarian or similar motives. Persons performing military service also may develop conscientious objections.
- (b) States that do not have such a system are called upon to establish independent and impartial decision-making bodies with the task of determining whether a conscientious objection is genuinely held in a specific case, taking account of the requirement not to discriminate between conscientious objectors on the basis of the nature of their particular beliefs.
- (c) States with a system of compulsory military service are recommended to provide for conscientious objectors various forms of alternative service which are compatible with the reasons for conscientious objection, of a non combatant or civilian character, in the public interest and not of a punitive nature.
- (d) States should take the necessary measures to refrain from subjecting conscientious objectors to imprisonment and to repeated punishment for failure to perform military service.
- (e) States, in their law and practice, must not discriminate against conscientious objectors in relation to their terms or conditions of service, or any economic, social, cultural, civil or political rights;
- (f) States, subject to the circumstances of the individual case meeting the other requirements of the definition of a refugee as set out in the 1951 Convention relating to the Status of Refugees, are encouraged to consider granting asylum to those conscientious objectors compelled to leave their country of origin because they fear persecution owing to their refusal to perform military service when there is no provision, or no adequate provision, for conscientious objection to military service.
- (g) States recognize the importance of the availability of information about the right to conscientious objection to military service, and the means of acquiring conscientious objector status, to all persons affected by military service.

The Commission also passed a resolution 2000/34 on April 20, 2000 calling upon States to review their current laws and practices concerning conscientious objection in the light of its resolution 1998/77. In addition, the Commission requested the Office of

the United Nations High Commissioner for Human Rights to prepare a compilation and analysis of the best practices on conscientious objection, to seek such information from Governments, organizations of the UN and NGOs, and to submit a report containing this information to the Commission at its fifty-eighth session in 2002.

#### (2) Human Rights Committee

The United Nations Human Rights Committee established by the ICCPR, following the aforementioned resolutions of the Commission, has held the position that each State shall not punish conscientious objectors and the right of conscientious objectors shall be guaranteed as one of the basic human rights. Especially, the Human Rights Committee adopted the General Comment in 1993 that the right of conscientious objectors derives from Article 18 of the ICCPR concerning the rights of conscience and religion, and conscientious objectors shall not be punished for the failure of performing military service. (CCPR General Comment 22[48], Para.11, 30/07/93)

# B. RESPONSIBILITY AND OBLIGATION OF THE KOREAN GOVERNMENT CONCERNING CONSCIENTIOUS OBJECTION

The Republic of Korea clearly supports the principle of respect for international law, by stipulating in the Article 6(1) of the Constitution that "treaties duly concluded and promulgated under the Constitution and the generally recognized rules of international law shall have the same effect as the domestic laws of the Republic of Korea." As the Republic of Korea signed the ICCPR in April 1990, and became a member of the UN in September 1990, it is obligated to respect the resolution on human rights of the UN and to perform its responsibility to protect human rights provided by the Charter of the UN, the Universal Declaration of Human Rights and the ICCPR.

The Republic of Korea, in its second periodic report to the Human Rights Committee, reported that "pursuant to Article 6(1) of the Constitution, as the ICCPR was ratified and promulgated by the Government with consent from the National Assembly, the ICCPR has the authority of domestic law without requiring additional legislation. Accordingly, the Administration and the Court are obliged to observe the ICCPR when exercising their powers [...] In the event that a law enacted prior to the ICCPR's ratification conflicts with its provisions, the ICCPR has greater authority." (CCPR/C/114/Add.1, Second periodic reports of States parties due in 1996, 20/08/98, para.9) That is, the Korean Government recognized the ICCPR as having the same effect as domestic law without additional legislation.

Further, the Republic of Korea expressed the meaning of "the same effect as domestic law" in its initial report of States parties to the Committee Against Torture;

"In case domestic law conflicts with the Convention against Torture arises, according to the general rule of international law, the lex posteriori rule and the principle of the precedence of special law shall be applied." (CAT/C/32/Add.1, Initial reports of States parties due in 1996 State Party Report English, 30/05/96, para.20) The Republic of Korea also expressed the principle in the paragraph 10 of the aforementioned Second periodic report that "No law enacted in the Republic of Korea may encroach on the rights provided in the ICCPR; any such law would be viewed as unconstitutional." That is, it recognizes that the ICCPR has the same effect as domestic law promulgated by the National Assembly, and domestic law is not effective as long as it conflicts with the ICCPR. Therefore, the Republic of Korea has the responsibility to guarantee human rights stipulated in ICCPR and to abide by the relevant resolutions or recommendations of the Commission or the Human Rights Committee.

As stated above, the Human Rights Committee adopted the General Comment that the right of conscientious objection derives from Article 18 of the ICCPR, and conscientious objectors shall not be punished for the failure of performing military service. Thus, the Republic of Korea should take the measure to recognize conscientious objection as one of human rights that every citizen enjoys. Moreover, the Republic of Korea has to provide for various forms of alternative service, which conscientious objectors can opt for instead of military service, and so to establish the system in which conscientious objectors are not punished as a form of criminal penalty.

Especially, the Republic of Korea, having voted in favor of the resolution 2000/34 of the Commission, is obligated to report to the Commission the laws and practices on the conscientious objection in Korea. In Korea, conscientious objectors have been punished, without exception, with severe criminal penalty. Worse than this, they have been seriously discriminated as to be unable to have adequate job even after finishing their imprisonment. This shows that the Republic of Korea has not performed its responsibility and obligation to the ICCPR, and has not fulfilled completely the resolutions of the Commission and the Human Rights Committee.



# **Present Situation of Conscientious Objection in Korea**

#### A. MILITARY SERVICE SYSTEM OF KOREA

The Republic of Korea is enforcing the conscription system, based on Article 39(1) of the Constitution, which provides that "All citizens have the duty of national defense under the conditions as prescribed by law," and Article 3(1) of the Military Service

Act, which stipulates that "Any man who is a nationality of the Republic of Korea shall perform faithfully military service under the conditions as prescribed by the Constitution of the Republic of Korea and this Act." Military service is classified into 'active service', 'supplementary service' and 'reserve service'.

The term of active service is from 26 to 30 months including 6 weeks of basic military training. Supplementary service is for those who are judged to have a physical defect or a low level of school education or to have a special skill or qualification as provided by the Military Service Act. The term of supplementary service is from 32 to 36 months including 4 weeks of basic military training. Those who have finished their active service as the ranks are compulsorily subject to reserve service for another 8 years. Exemption from military service is limited to those who are physically defective, under-educated or responsible for household matters as provided by the Military Service Act, but there is no exemption provision for conscientious objectors.

According to the White Book 2000 published by the Ministry of National Defense(MND), out of the Korean population of 48 millions, those who served active service were 690,000, and those who were deployed to supplementary service due to a physical defect or a special skill were about 140,000. According to the statistics of the Military Manpower Administration(MMA), 4,916 persons, 2.6% of those who took physical examination for conscription during the first half of the year 2001, were exempted from military service due to physical or educational inadequacy. Except for those who have a special skill or qualification such as expert researchers, industrial skilled men, the MMA is the only authority that makes a decision on standards for conscription such as a physical defect or a level of school education. Therefore, conscientious objectors, who do not have any skill or qualification and are adequately educated with no physical defect, cannot apply even for supplementary service. Article 88 of the Military Service Act stipulates that persons who fail or refuse to comply with the notice of enlistment shall be punished by imprisonment for not more than three years, and Article 44 of the Military Penal Code stipulates that any person who disobeys a superior's lawful order in time of peace shall be punished by imprisonment for not more than three years.

#### B. ACTUAL SITUATION OF CONSCIENTIOUS OBJECTORS IN KOREA

As of December 2001, total 1,640 conscientious objectors including 91 persons whose cases are pending are serving their sentence in national prisons. Considering that their term of a sentence is usually 3 years, it is estimated that until recently about 600 conscientious objectors chose to go to prison instead of raising guns every year. The number of conscientious objectors in Korea has increased for the last 62 years



since the first record of conscientious objectors was made in 1939 during the period of Japanese Imperialism, and the cumulative number of conscientious objectors punished is about more than 10,000 until now.

They have been excluded from the favor of parole which has been implemented on regular basis as well as on national holidays, and they have not been included with the objectives of amnesty or reinstatement which have been made several times a year. Therefore, the conscientious objectors are living with social disadvantages due to criminal records. They are not eligible to be appointed as a public officer due to their criminal records after being released, and in case that they try to enter into private companies they experience social discriminations such as being eliminated from identification inquiry, etc. In Korea, most of conscientious objectors are Jehovah's Witnesses and some of them are believers of the Seventh-day Adventist church, etc. According to the report by the MND submitted to the National Assembly for the Parliamentary Inspection to the Government Offices in 2001, the number of conscientious objectors sentenced from 1992 to 2000 is showed as following Table & Figure 1:




80 % of conscientious objectors who are on trial or in prisons have been routinely sentenced to 3-year imprisonment based on Article 44 of Military Penal Code by military courts before the latter half of the year 2001. Since the latter half of the year 2001, because most of conscientious objectors refused to comply with a notice of enlistment, they have been applied to the Military Service Act instead of the Military Penal Code, and thus, they have been sentenced to 18~26 months' imprisonment by civil courts and are serving their sentence. According to the present Military Service Act, persons are exempted from military service when being sentenced to one and a half years or more. Taking into consideration of this exemption term, civil courts usually sentences them to one and a half years' imprisonment. The Constitution of

Korea provides that a suspect is presumed to be innocent until he/she is given a finalization of trial procedure of guilty, and a general principle of the Criminal Procedure Law is that a suspect, who seems not to run away or destroy the evidence, should be tried without physical confinement. However, conscientious objectors have been usually kept in custody from the start of their criminal investigation. As of December 2001, the distribution of 1,640 conscientious objectors by prison term is showed as following Table & Figure 2. In the case of Jehovah's Witnesses, the number of conscientious objectors whose family members were also imprisoned on the charge of conscientious objection is not small, and the number is shown in the Table 3.

The most urgent matter, which should be immediately improved among the matters related to human rights of conscientious objectors in prison, is the problem in applying the present parole system to them. According to the eligibility criteria for parole<sup>2</sup>, conscientious objectors from Jehovah's Witnesses are classified as a special case, though they are usually regarded as the best-behaved prisoners. That is, even though the best-behaved prisoners usually receive the favor of parole after serving the half of their prison term, conscientious objectors can apply for a parole after serving 27 months(75% or longer of 3-year prison term) without exception. This definitely partial regulation is intentionally to extend the application period for parole to make them serve longer period than the 26-month period of active service under the Military

Service Act. Moreover, prisoners practicing other religions are permitted to enjoy religious activities such as priests' visit from outside on a regular basis, but the Jehovah's Witnesses in prison are not permitted to do any religious activity, because they objected to military service on the ground of religious belief.

#### C. STANDPOINT OF THE MINISTRY OF NATIONAL DEFENSE(MND)

On October 23, 2001, the Ministry of National Defense(MND) announced its standpoint on conscientious objection<sup>3</sup>, emphasizing that the military service is a fundamental agreement for national defense and that an alternative service for conscientious objectors is impossible, because it could be a special favor for a specific religion. The MND added that when an alternative service for conscientious objectors is implemented, a serious problem would occur from the viewpoint of equal duty for national defense and the spreading of mutiny would cause a serious damage to the national defense under the confronting situation of North and South Koreas.

#### D. ATTITUDE OF JUDICIARY

#### 1) Supreme Court's Interpretation on Conscientious Objection

Before the constitutional court system was established based on the revised Constitution in 1987, the Supreme Court had been the highest institution in Korea, which could deliberate the constitutionality of laws. Conscientious objectors in Korea, by appealing to the Supreme Court in 1969, 1985 and 1992, have insisted that their conscientious objection is not a violation of the duty of national defense, because their conscientious objection is from the freedoms of religion and conscience. The Supreme Court, however, repeatedly rejected their appeals by ruling "the conscientious decision of individuals to object to military service on the ground of religious beliefs is not applicable to the freedoms of religion and conscience which the Constitution guarantees." Based on these rulings, courts have given conscientious objectors the verdict of guilty without exception until now.

# 2) Court's Application for the Constitutional Court to Deliberate the Constitutionality of the Military Service Act

On January 29, 2002, Kyeong-Soo Lee whose case was on trial at the Southern Branch Court of the Seoul District Court submitted an appeal to the Constitutional

# E. RESPONSE OF THE NATIONAL ASSEMBLY: SOME ASSEMBLYMEN' ATTEMPT TO SUBMIT A BILL

When conscientious objection became a social hot-issue last year, Jeong-Bae Cheon(the Millennium Democratic Party) and Yeong-Dal Jang(the Grand National Party) prepared a bill to introduce an alternative service system and promoted to hold a public hearing respectively, but they deferred the submission of the bill because of strong oppositions from conservative Christian churches. Now any movement to legislate the alternative service system is not going on.

#### F. TREND OF PUBLIC OPINION

Generally, the Korean society has regarded Jehovah's Witnesses who have objected to saluting the national flag and blood transfusion as well as to joining in military service as a particular sect of Christian churches, and such beliefs have not been welcomed to the public. However, when the fact that more than 10,000 believers of Jehovah's Witnesses were sentenced to imprisonment because of their conscientious objection began to be widely known, people started to have compassion toward Jehovah's Witnesses. Arguments over the freedoms of religion and conscience are increasing and a majority of citizens who participated in various surveys through the internet, expressed favor for the adoption of an alternative service system not to send conscientious objectors to prison.

Except for the MND, in Korea, the biggest dissident groups against the adoption of an alternative service system and the safeguarding of human rights of conscientious objectors are conservative Christian churches. The Christian Council of Korea, the representative of conservative Christian churches in Korea, gave out a statement that the legislation movement for the introduction of alternative service is only to give a special benefit to the heresy.<sup>4</sup> Other religious groups, however, have a favorable opinion about the alternative service system, though they are not so active, and the Buddhist society is preparing an active movement to urge the introduction of

alternative service system, as Tae-Yang Oh, a Buddhist and peace activist, declared his conscientious objection in December 2001.

Since spring of 2001, various groups in the Korean society such as academic circles, religious circles, etc. have held many discussions about conscientious objection and the introduction of alternative service system. Generally the opinion is overwhelming that conscientious objection is based on the freedoms of religion and conscience stipulated in the Constitution, and that thus alternative service system should be adopted. Opposers to the introduction of alternative service system insist that the introduction of alternative service system is a partial favor for a specific religion and threat to the national security under the divided situation of the Korean Peninsula, and that it causes a partiality in the military service. Nevertheless, they also concede that human rights of conscientious objectors in prison should be improved. On February 4, 2002, a manifesto, urging the recognition of right to conscientious objection and the adoption of alternative service system, was given out under the joint signatures of 1,552 people including renowned persons of academic world, political world, legal world, media world, civil groups and social groups, etc.<sup>5</sup>. In this manifesto, they also called upon the Korean government not to punish conscientious objectors any more.

#### G. ACTIVITIES OF CIVIC GROUPS

Since March 2001 when the story of the conscientious objectors of Jehovah's Witnesses became known in a forum related to human rights issues in the military, the activities of civic groups have helped them on full-scale. Civic groups have organized various kinds of forums, social gatherings to publicize the issue of conscientious objection, and dispatched delegates to examine alternative service systems in Taiwan and Germany. And MINBYUN-Lawyers for a Democratic Society, a legal group which has defended political prisoners, organized a defense counsel to support conscientious objectors in their trials. As the result of these efforts, the Korea Solidarity for Conscientious Objection(KSCO), in which over 30 distinguished civic groups such as People's Solidarity for Participatory Democracy, Korean Federation for Environmental Movement, People's Solidarity for Peace and Human Rights, National Federation for Buddhists' Movement, National Professors' Council for Democratic Society, Lesbian Gay Human Rights Federation participated, was organized and is operating. The KSCO has a plan to prepare a bill for legislation to adopt an alternative service system at the National Assembly, to give an advice to young people, who will be enlisted, to publicize conscientious objection and the alternative service system, and to arouse public interest through national and international activities.



#### Conclusion

The fundamental human rights of Korean people have been infringed under the military dictatorial regimes for a long time, but the Republic of Korea has been taking procedures to go to a democratic society after the installation of a civilian government in the early stage of 1990s. Also, in November 2001, the National Human Rights Commission was established, and it is expected that general situation of human rights will be qualitatively improved step by step. Article 10 of the Constitution of Korea stipulates that "All citizens are assured of human dignity and value and have the right to pursue happiness." The Constitution imposes the duty of national defense on citizens by law, and guarantees the freedoms of religion and conscience as well. Therefore, the introduction of a proper form of alternative service that conscientious objectors can opt for is not contradictory to the duty of national defense stipulated in the Constitution. Nevertheless, the Korean government has only punished conscientious objectors with heavy sentences without exception, and they have not enjoyed the freedoms of religion and conscience, and their rights for human dignity and value and rights for the pursuit of happiness, which all human beings should enjoy as the highest ideas based on the Constitution, have been infringed upon. If the present military service system is not changed, the disadvantage of and discrimination against conscientious objectors will continue.

The standpoint of the Korean government which has treated conscientious objectors as felons until now, is clearly against the relevant resolutions of the Commission on Human Rights of the UN and the recommendations of the UN Human Rights Committee, which have urged each State to guarantee conscientious objection as one of human rights stipulated in the ICCPR. The Korean government should properly report the present conditions of conscientious objection in Korea to the UN and make a sincere effort to correct the related problems based on international human rights laws. There is no obstacle to introducing an alternative service system with public service nature, which conscientious objectors can liberally choose without being imprisoned. Therefore, the Korean government, pursuant to the relevant resolutions of the UN, should immediately adopt an alternative service system, and abolish the laws and regulations that punish conscientious objectors. In addition, for the conscientious objectors in prisons now, all discriminations related to their religious activities should be corrected and proper paroles should be given to them as soon as possible.

As Tae-Yang Oh, a Buddhist and pacifist, declared his conscientious objection to military service in December 2001, the issue of conscientious objection is being developed into a pan-national and pan-religious human rights matter. The anxieties of

the Korean government, saying "the consideration of the human rights of conscientious objectors and the adoption of alternative service for them will be a threat to national security due to the confronting situation of North and South Koreas", will be satisfactorily solved by a social agreement which is the basis of democracy and the establishment of a reasonable system. Exemplary cases in many countries which have implemented various alternative services from a long time ago show that these anxieties are just groundless fears caused by militarism which has ruled people's consciousness under military dictatorial regimes until now. Dae-Jung Kim, President of the Republic of Korea was awarded the Nobel Peace Prize in December 2000 for the first time in Korea. The conscientious objectors are the most peaceful people with a conviction not to hurt anyone or to use violence on whatever reason. The human rights policy of the Korean government, which is appropriate for the winning of Nobel Peace Prize, should start from the protection of human rights of conscientious objectors.

#### » APPENDIX 1

#### Provisions of the Korean domestic laws concerning Conscientious Objection

#### **The Constitution**

Article 6 [Treaties, Foreigners]

(1) Treaties duly concluded and promulgated under the Constitution and the generally recognized rule of international law have the same effect as the domestic laws of the Republic of Korea.

Article 10 [Dignity, Pursuit of Happiness]

All citizens are assured of human dignity and value and have the right to pursue happiness. It is the duty of the State to confirm and guarantee the fundamental and inviolable human rights of individuals.

Article 19 [Conscience]

All citizens enjoy the freedom of conscience.

Article 20 [Religion, Church]

(1) All citizens enjoy the freedom of religion.

Article 39 [Duty to Military Service]

÷,

(1) All citizens have the duty of national defense under the conditions as prescribed by law.

#### Military Service Act

Article 3 (Duties of Military Service)

Any man who is a nationality of the Republic of Korea, shall perform faithfully
military service under the conditions as prescribed by the Constitution of the
Republic of Korea and this Act.

Article 88 (Evasion of Enlistment)

(1) Persons who have received a notice of enlistment or a notice of call (including a notice of enlistment through recruitment) in the active service or the call (including a notice of appointment to the active service by application), and who fail to enlist in the army or to comply with the call, even after the expiration of the following report period from the date of enlistment or call, without any justifiable reason, shall be punished by imprisonment for not more than three years:

- 1. Five days in cases of enlistment in active service;
- 2. Three days in cases of public interest service personnel call;
- 3. Three days in cases of a call for education; or
- 4. Two days in cases of a military forces mobilization call and a wartime labor call

#### Military Penal Code

#### Article 44

Any person who defies or disobeys a superior's lawful order shall be punished according to the following classifications:

- 1. In case it is in the face of enemy, he shall be punished by death, life imprisonment at hard labor, or imprisonment at hard labor for not less than ten years;
- 2. In case it is wartime, during an incident, or in a martial law area, he shall be punished by imprisonment at hard labor for not less than one year and not more than seven years; and
- 3. In all other cases, he shall be punished by imprisonment at hard labor for not more than three years.

#### Standpoint of the Ministry of Defense on alternative service for conscientious objectors

October 23, 2001

The Ministry of Justice makes clear its standpoint as follows on the conscientious objection of a specific religious group with which the media are dealing as a social issue, how it affects the national defense and the common sense of the Korean society on the obligation of military service.

The obligation of military service forms a basis of the democratic civil awareness that is "citizens can exist as long as the State exists", and also reflects a fundamental social agreement for the existence of a State. We have enjoyed freedom and happiness despite numerous invasions from other countries because of the sacrifices of common and virtuous consciences, and because of their performing duties as a citizen even now.

But, as an opinion, which insists that conscientious objectors should be permitted an alternative service for several reasons such as the prevention of increasing criminals, the protection of minorities' human rights, etc., is gaining power, this matter is being misunderstood as a matter related to human rights and the security of national benefit.

The military service system was decided based on various factors such as political and economic situations, social and cultural traditions, and defense conditions of a country. However, conscientious objectors in Korea are requiring a special favor of exemption from the obligatory military service including the basic military training and the 8-year reserve service, without considering our special defense situation of the divided Korean peninsula and the people's expectation for the implementation of impartial obligatory military service. The conscientious objectors are insisting that if the period of alternative service is long and they are allowed to serve in poor and hard fields, the fairness of service will be respected. But we should keep in mind that it is not a matter of service period but a matter of country's existence related to this question "who will perform a military service risking his life?".

Especially, the Republic of Korea has lots of various religions comparing to other countries, and the Constitution guarantees the freedom of religion and also stipulates that everyone should not be treated 'discriminately' and also should not receive a 'special favor'. Recently, social concerns about conscientious objection and opposition to conscription are spreading through many meetings and international joint seminars. But we should consider the question, "how can we safeguard the conscience and morale of soldiers who are keeping the basic promise as a citizen of a democratic country for the security of the nation even now?".

In conclusion, the objection to military service is an objection to the basic duty to keep our freedom and rights under our special defense situation of the divided Korean peninsula. Therefore the Ministry of Justice makes sure that any alternative service for conscientious objectors cannot be accepted under the present defense situation and conscription system not only because it will disturb the fairness of obligatory military service system but also because it will disturb the unification of people due to the dispute of a special favor for a specific group.

#### Statement by the Christian Council of Korea

June 1, 2001

We, the Christian Council of Korea, strongly object to the legislation of an alternative service system for 'Jehovah's Witnesses' who object to the obligatory military service.

Recently, Jeong-Bae Cheon(assemblyman of the Millennium Democratic Party) and Yeong-Dal Jang(assemblyman of the Grand National Party) are preparing for presenting a bill on a so-called 'alternative service system' for conscientious objectors based on their beliefs, which would permit them to perform public services instead of being punished and extend the period of their service term. We, Korean churches, object to this legislation on the adoption of alternative service system and the revision of the Military Service Act, which would endanger our nation and foster a sense of social incongruity.

According to recent television programs of KBS and MBC and the articles of 'Hankyorye 21', it was shown that 'Jehovah's Witnesses' are maneuvering the movements behind and it is sure that the legislation is a special favor for them. Everybody knows that 'Jehovah's Witnesses' is a heresy wearing a mask of Christianity and has caused social problems such as 'objection to being armed(evasion of military service)', 'objection to blood transfusion', 'objection to saluting the national flag', etc.

The reason why Jehovah's Witnesses object to military service is because they regard nations and governments as organizations of Satan. If they insist that they cannot participate in wars killing people and be armed because of their conscience based on their religious beliefs, they are deceiving their own conscience. An opinion, which considers Jehovah's Witnesses as conscientious religionists conniving at their bad effects by insisting the freedom of religion and the guarantee of minorities' human rights, is very dangerous.

This legislation will cause big ill effects. It is because there are religions prohibiting killing lives, any religion could make a theory to object to conscription order or war, and it is expected that a new religion that takes advantage of objection rights would appear. And, since nobody can prohibit anyone to convert his/her religion, there are many possibilities that draft dodgers make bad use of the alternative service system.

# Manifesto urging the recognition of right to conscientious objection and the adoption of alternative service system

After the stories of Jehovah's Witnesses who refused to be armed based on their beliefs were broadcast through many news media last year, another human right issue 'conscientious objectors' is on the rise in the Korean society. There have been more than 10,000 conscientious objectors due to the spreading of religious prejudice and conservative defense viewpoint in Korea since the establishment of national military force. Nevertheless, their existence has been hidden so far.

Conscientious objectors mean those who object to obligatory military service such as by conscription based on their 'conscience' or object to participating in a war or armed action directly or indirectly. Conscientious objectors in Korea are to be imprisoned as criminals who violate the positive law of Korea. Right now, around 1,600 conscientious objectors are in prisons in Korea because they were treated as evaders of the military service, and the number of conscientious objectors is increasing. Because they have been excluded from the objects of amnesty and reinstatement, they are living with their criminal record by resigning themselves to social discriminations. Furthermore they are also excluded from general paroles and are suffering unjust treatments in that they are granted a favor of parole only after having served 27 months in prison, which is longer than the term of active service for a soldier. There are many cases that a father and his son were imprisoned for two generations or that brothers in the same family were imprisoned for the same reason. Of course, recently some of conscientious objectors were given a 6-month mitigation of penalty as a benevolent decision, but the Korean government doesn't promote any discussion about the human rights of conscientious objectors and the right to conscientious objection.

Even though 'the right to conscientious objection' is being settled down in international society as one of universal human rights, the Korean society still has its conservative opinion that "the freedom of conscience guaranteed by the Constitution is not restricted only within one's mind but can be restricted when it is expressed outside whether positively or even passively". The possibility of a reasonable system, which respects the rights of conscientious objectors and allows them to serve for the nation in other methods, is fundamentally blocked.

In more than 40 countries in the world, the right to conscientious objection is guaranteed by the Constitution and related laws of each country. Also, many countries are positively implementing alternative service systems, which allow conscientious objectors to serve as noncombatant in troops or serve in social welfare institutions such as homes for the aged, facilities for the handicapped, etc. And many kinds of international agencies including the United Nations recognize the right to conscientious objection as a human right, and strongly recommended through many resolutions that each State should recognize the right to conscientious objection and prepare a proper system for that.

In the year 2000, Taiwan adopted a comprehensive alternative service system and actually improved the human rights situation of conscientious objectors. The reason why Taiwan, which also has a situation militarily confronting with China like the Korean Peninsula, could adopt this

kind of alternative service system is because it concerned human rights of conscientious objectors who had been imprisoned and because it accepted the utilitarianism of an effective distribution of manpower. In the case of Germany, its Constitution stipulates the right to conscientious objection and there are many conscientious objectors who are 30% of the total conscription objects. Their service fields are very various in many sorts of social welfare, and it is well known that their existence has considerably contributed to the construction of Germany as a welfare country. Like this, alternative service system already has a long history in more than 20 countries around the world including Taiwan, Germany, Denmark, Austria, etc.

In Korean, more than 600 conscientious objectors are sent to prisons instead of taking arms every year, and about 1,600 conscientious objectors are in prisons now. Since the adoption of conscription system, the number of conscientious objectors is increasing. And this matter is raising its head as a matter of conscience and the practice of young men's conscience who are about to be conscripted is not just a matter of a specific religion because Tae-Yang Oh, a Buddhist and pacifist declared his conscientious objection. Until now, the matter of conscientious objectors has been regarded as a unique practice of a specific religion rather than as a human rights issue. This narrow-minded understanding have interrupted social approaches and practical discussions related to conscientious objection. However, Korea already has various alternative services guaranteed by the present Military Service Act such as social services and other forms of exemption system. So, the preparation of an alternative service plan for the improvement of human rights of conscientious objectors will be easier than the case of Taiwan. Especially the anxiety that "the recognition of the right to conscientious objection and the adoption of an alternative service system would be a threat to the national defense in the situation of the divided Korean peninsula", will be sufficiently overcome by means of a social agreement based on democracy and the preparation of a reasonable system. Considering many cases in other countries, which have already implemented alternative services, it is shown that this anxiety is just a groundless fear due to militarism.

Under all circumstances, the freedom of conscience guaranteed by the Constitution should be respected. National power and social-cultural violence that exclude and isolate conscientious objectors should never be tolerated. Till when will their conscience be thrown into prison? The protection of human rights of minorities including conscientious objectors is an important responsibility that a real democratic society and human rights country should bear. If there is a method that respects the conscience of individuals and serves for the benefit of a country, it should be positively considered and realized.

The Korean government and the National Assembly must immediately start to discuss the adoption of an alternative service system for conscientious objectors!

Discriminative treatment against conscientious objectors in the application criteria of parole deliberation should be immediately redressed!

We object to the policy of custody-investigation against conscientious objectors. Conduct the investigation of Mr. Tae-Yang Oh without him in custody!

#### Conscientious objectors fight war against war

(Jan 11, 2002) Oh Tae-yang, a 26-year-old vegetarian pacifist who spends most of his time volunteering at a homeless shelter and a soup kitchen for the elderly, made a decision last March that will alter the course of his life. After making every effort to delay his military service, a two-year obligation for all able-bodied Korean men once they finish their education, Oh decided to refuse to join, on moral and religious grounds. In December, when he received his conscription notice, he did not report for duty within the required five days, knowing that he faced a jail term and lifelong criminal record. Oh, a Buddhist, is Korea's first conscientious objector outside the Jehovah's Witness faith. There are now 1,600 Jehovah's Witnesses in prison for refusing to perform military service, according to Chung Woon-young of the Watch Tower Bible and Tract Society of Korea, an organization that represents the minority religious group. Jehovah's Witnesses believe they are following in the footsteps of the early Christians, who refused to serve in the Roman army, says Chung. Then as now, he says, conscientious objectors were asked who would defend the empire if individuals were allowed freedom of conscience. Their answer is the same as that of their predecessors: continuing to practice their faith and following the Bible's directive to love their enemies. Raised in a Protestant home, Oh converted to Buddhism as an adult and has been involved in several peace and human rights efforts, including opposition to the U.S.-led military campaign in Afghanistan. The Buddha, Oh says, stood for nonviolence and taught that all living beings fear death. Therefore, harming or killing another person in war, or learning to use guns and other weapons of war, would violate his religious and moral beliefs. Under Korean law, the minimum requirement is two years and two months of Army service for all men designated as healthy and physically fit. The Navy and the Air Force require somewhat longer terms. Civilian forms of service - which may involve various desk jobs or enforcement of traffic laws - are available only to those with health problems, while those with serious disabilities are excused. No exemptions based on religious or moral convictions are granted, making the Korean system unlike that of Taiwan, where conscientious objectors can opt for civilian duties. There are, however, special programs for certain highly qualified professionals, who are allowed to sign work contracts for several years after four weeks of combat training. Hong Young-il, a graduate of Seoul National University with a degree in electronic engineering, qualified for such a program, but as a Jehovah's Witness, he deemed it unacceptable. In 1990, when he was 27, he was put in a military prison to await sentencing. There, he says, he was beaten, deprived of sleep and not allowed to use the bathroom. Chung, also a conscientious objector, alleges similar abuses in a military prison in 1975, where he says military police killed his friend, Lee Chun-gil. Conditions for Hong improved upon his transfer to a civilian prison, where he was sent after a three-minute trial in which a judge handed down the mandatory two-year sentence. However, Hong said, he was not allowed to read religious magazines in prison or attend religious services, which are available to other prisoners. Hong's mother was heartbroken over her son's decision because he had such a "bright future," and his criminal record proved a major obstacle to his career. Five years after his release, he was finally able to obtain employment in his field, and his mother - although not a Jehovah's Witness herself - now understands how important his beliefs are to him.

Oh has faced attacks from strangers on the Internet who question his sincerity and call him a "draft dodger," but those around him are supportive. His two sisters strongly support his decision, and one is producing a documentary film about conscientious objectors in Korea. Oh emphasizes that not all Buddhists interpret the Buddha's teachings as a prohibition on war, and he is not condemning the choice of other Buddhists to serve in the military. He believes Korea should make military service optional, as it is in many other countries such as Britain, the United States, France and Israel. "It's a human rights issue," he says, adding that Korea is being watched internationally and that many nongovernmental organizations support his struggle, including People's Solidarity for Participatory Democracy, Minbyun, Sarangbang and Solidarity for Peace and Human Rights. In October, Amnesty International sent a delegation to Korea to meet with some of these groups, as well as government representatives, to discuss several pressing human rights issues. In a statement, the organization urged the Korean government to release all conscientious objectors, calling them "prisoners of conscience," meaning they are persecuted for their beliefs. The group said in the statement, "By detaining them, the government denies them the right of freedom of conscience, faith and expression as enshrined under the International Covenant of Civil and Political Rights, to which the Korean government is a state party. ... the Korean government should consider a civilian alternative which is not punitive, and which is completely civilian in nature for conscientious objectors." The Ministry of Defense sees the matter differently. In an official statement, it classed military service as a civic duty on a par with paying taxes, asserting that it is "not a matter of choice subject to an individual's conscience or religious beliefs." The ministry said refusal to serve in the military for religious reasons is "an act of abandoning responsibility for national security," and that introducing an alternative would be "tantamount to authorizing anti-national and anti-social activities." Despite the opposition from officials, Chung says there have been positive developments in this area. Last year, the issue gained unprecedented media attention and public sympathy for conscientious objectors in Korea. Legislation was proposed that would have allowed them to perform an alternative civilian service, but the move was unsuccessful, in part because of opposition from a Christian group that disagrees with the Jehovah's Witnesses' pacifist stance. A new bill is currently under review, Chung says, and is supported by major religious groups, legislators from several parties, and many legal experts. Cases are no longer tried in military courts, Chung adds, meaning conscientious objectors do not have to go to military prisons, and civilian court judges can impose a "lenient" sentence of a year and a half, instead of the mandatory three-year sentence required by a military court, where offenders have no chance of parole before two years and three months. It remains to be seen whether parole will be granted in the new cases, he says. Oh describes his chances of avoiding jail as "slim," but says he hopes his case will pave the way for conscientious objectors' rights in the future. When asked to comment on accusations of disloyalty to their country, Chung and Hong say they frequently face such attitudes. But, Chung says, their faith teaches that all humans are part of the same family, and contends that this faith would hold even in the event of a foreign invasion. "We're all descendants of Adam and Eve," Chung says, adding that 10 million South Koreans have relatives in the North. He says visiting representatives of Amnesty International expressed great surprise that Jehovah's Witnesses were the country's only conscientious objectors. "When you think about that," he asks, "who is doing the right thing, people who object to military service, or people who don't?" (eileencahill@hotmail.com) By Eileen Cahill Staff reporter

#### Judge Suggests Revision of Law to Allow 'Conscientious Objection'

(Feb 1, 2002) A district judge has filed an official request to the Constitutional Court calling for a review of the constitutionality of the current Military Service Law that refuses to recognize any form of conscientious objection military service. Provisionally sustaining the claims of a 21-year-old man indicted on charges of evading military service, senior judge Park Si-hwan at the Seoul District Court filed a request with the Constitutional Court Tuesday to determine the constitutionality of Section 88 of the Military Service Law, which stipulates that those who refuse the draft are subject to up to three years in prison. Upon filing the request, judge Park suspended the trial and released the defendant on bail. The trial will resume only after the Constitutional Court rules on the constitutionality of the disputed clause. "When there is a conflict between the duty of military service and basic constitutional rights like freedom of thought, conscience and religion, they should be harmonized and rendered compatible with each other." Park said. "The present court considers Section 88 of the Military Service Law, which refuses to acknowledge any form of conscientious objection to military service on any grounds, including religious or political beliefs, to be a potential threat to a conscientious objector's dignity and pursuit of happiness," the judge added. Explaining that there are many countries which recognize conscientious objectors and offer them alternatives to serve their country in different ways, Park said it was high time South Korea considered such policies in light of constitutional rights. Under a compulsory military service system, every South Korean male is required to serve his country, with the most common form being a 26-month stint in the Army. The defendant, identified only by his family name Lee, joined a religious community in 1995 that bars its members from taking up arms. He was arrested and indicted in December last year after refusing to be drafted. Many judges seem to think conscientious objectors should be given different treatment from those who try to evade military service by bribing doctors or officials. There seems to be a consensus among judges that at present conscientious objectors should be sentenced to exactly 18 months without probation, the minimum punishment necessary to secure a draft exemption for the convicted who served the term. Two conscientious objectors received exactly that same prison sentence Thursday from the First Appellate Panel of the Seoul District Court. At their first sentencing, they had received two years in prison without probation and eight months in prison with a two-year probation, respectively. The appellate ruling decided to "equalize" the prison terms so as to make them exempt from the draft after serving the minimum period of time possible for that purpose. One of the defendants had to request the prosecution to file an appeal seeking an increase in his prison term and a removal of the probationary suspension, instead of filing an appeal himself, because defendants cannot appeal directly for a longer sentence.

[Editorial] Too Premature for `Conscientious Objection'

(Feb 1, 2002) The Constitution stipulates in Article 39 that all the people are obliged to serve in the

armed forces for the defense of the nation, as required by related laws, and no one shall be subject to disadvantages from the obligatory military service. Hence, the "sacred duty to safeguard the nation" has been one of the most important events in the life of young Korean men, and shirkers of military service have been given strict criminal punishments in accordance with laws. The recent fierce public criticism of hip-hop star Yoo Seung-joon definitely shows the people's general view of the Constitutional provision. Yoo had promised on numerous occasions to become a "proud" Korean man by serving in the armed forces, but became an American citizen and thus avoided enlistment. Yet, as time goes on, compulsory enlistment has been increasingly challenged by believers in specific religious sects, like the Jehovah's Witnesses and the Seventh-Day Adventists, who cite their so-called "religious conscience." According to the military authorities, about 600 people refuse to be drafted for religious reasons each year, and some 10,000 were criminally punished so far, with 2,000 serving prison terms. While the worrisome trend is being supported by some civic groups, a senior judge of the Seoul District Court on Tuesday ruled in favor of a 21- year-old man, a Jehovah's Witness, who was indicted for refusing on "moral grounds" to serve in the armed forces. The judge asked the Constitutional Court to determine if the Military Service Act, which punishes "conscientious objectors," is unconstitutional. The judge made the request after the defendant claimed that the draft law, which provides no alternative way to bear arms, was unconstitutional, and released him on bail of 3 million won. The judge has stirred up a major controversy as he called for the overhaul of the draft system, that he described as undermining the right to pursue happiness as stipulated by the Constitution. Those who reject the draft for religious reasons demand that the people's basic rights to act according to their conscience be guaranteed, while the defenders of the compulsory service, not to mention the military authorities and those who were already discharged, maintain that there can be no exception in fulfilling the sacred duty of defending the nation. In short, military service has special significance in Korean society since the nation suffered from numerous foreign invasions and is still technically at war with hostile North Korea, which started the devastating Korean War (1950-1953). Some civic organizations call for the protection of the human rights of "conscientious" objectors, and that alternatives for military service should be prepared for them. Those groups argue that the freedom of conscience and religion ensured by the Constitution should not be infringed upon by the Military Service Law, and other options, such as social service activities, need to be introduced. But the military authorities remain resolute about the taboo issue due to the need to confront the hostile enemy north of the border, citing the unfairness that will certainly arise by exempting people belonging to specific religious groups from military service. Indeed, such a privilege would give rise to a serious social problem, as many young people, for example, might become members of the religious groups to avoid enlistment, but later leave them when it suits their purposes. At present, freedom of religion is completely guaranteed at military barracks. Any soldiers with religions - Catholic, Buddhism or Protestantism - are allowed to conduct related activities while doing their military service. Some advanced countries, like Germany and Eastern European states, recognize conscientious rejection of enlistment, while Taiwan introduced an alternative formula for compulsory military service in 2000. However, the situation here in South Korea is quite different from that of such countries, as heavilyarmed troops have been confronting each other along the demilitarized zone for the past half century. It is too premature to debate on the issue.

#### [Editorial] Conscientious objection

(Feb 4, 2002) At long last, the nation has started to address a conflict between a right and a duty prescribed in the Constitution that has resulted in the imprisonment of quite a few young men refusing to serve in the military on the grounds of moral or religious principles. Every South Korean is guaranteed the right to freedom of thought, conscience and religion under the Constitution, which, at the same time, demands that all citizens perform the duty of national defense "under the conditions prescribed by law." Caught in the right-and-duty conflict is conscientious objection to military service, which South Korea is not considering to be a legitimate exercise of one of the inalienable rights accorded to its citizens. Now the nation has to tackle the problem of conscientious objection as a district court in Seoul has recently petitioned the Constitutional Court to rule on the law on military service. The request was filed during a trial last week on a detained Jehovah's Witness defendant, who claimed that he had a right to oppose military service on the grounds of his religious beliefs. We have high expectations that the Constitutional Court will pass a ruling in favor of conscientious objection, which the United Nations, as well as Amnesty International and other human rights groups, regards as a "legitimate exercise of the right to freedom of thought, conscience and religion." In its resolution adopted in 1998, the United Nations calls on states, which have yet to adopt conscientious objection in their legal systems, to establish "independent and impartial decision-making bodies with the task of determining whether a conscientious objection is genuinely held in a specific case." In South Korea, whose security is placed under a direct and immediate threat from North Korea, any attempt to avoid active duty has been regarded as so serious a crime that conscientious objection has drawn little attention from the public in the past. According to a news report, more than 10,000 conscientious objectors have served prison terms, and more than 500 young men, the majority of them being Jehovah's Witnesses, are sent to prison annually. Most tragic are the cases involving some parents who find nothing much to do when they see one son after another choosing to go to prison for their religious convictions. In a welcome development, however, public antagonism against conscientious objectors appears to be declining, albeit at a slow pace, in response to efforts made by the Lawyers for a Democratic Society, an activist group also called Minbyun, which has been forming defense counsel for them, and other domestic human rights groups that have been rallying behind them in the past. Even the court, one of the most conservative institutions in the nation, is moving in this direction with some appeals court judges reducing the lower court's sentences on conscientious objectors to one and a half years in prison, a minimum period required of them to serve if they are to be exempted from military service. It may not be too difficult to exclude conscientious objectors from active duty, given the fact that all women and quite a few young men, including some engineers in certain categories, are now exempted from active service, under the "conditions prescribed by law," though they are judged to be physically and mentally fit for the job. Whether or not to place conscientious objectors under the conditions of exception, too, and assign them to noncombatant alternative service will depend to a great extent on how the public will react to the proposal. One way to build social consensus in favor of objectors would be to promise strict rules on substantiating their claims to conscientious objection as a means of preventing others from exploiting it for self-interest and substantially extend the period of alternative service beyond that of active duty. At a time when the Constitutional Court is deliberating on the case of conscientious objection, the Ministry of National Defense needs to devise a plan for

alternative service. It also needs to study the possibility of assigning duties not requiring the use of weapons to persons whose beliefs allow them to serve in the military as noncombatants. As an interim measure leading up to permission to conscientious objection, the military court could show more leniency toward conscripts refusing to bear arms by departing from its customary practice of meting out the maximum three years in prison on convictions of disobedience.

#### Alliance supports conscientious objectors' rights

(Feb 5, 2002) Dozens of nongovernmental organizations formed an alliance yesterday with a mandate to gain recognition for the human rights of conscientious objectors in Korea. In a press conference in downtown Seoul, 29 civic and social groups called on the government to grant conscientious objectors an alternative to military service in the form of some other national service. The coalition also asked the government to overturn the current law, thereby pardoning those currently in prison for not joining the military on moral or religious grounds. "To protect the human rights of conscientious objectors in Korea, we are pushing to join hands with foreign governmental and nongovernmental organizations, including the U.N. Commission on Human Rights," said Choe Jun-seok, a coordinator of Lawyers for a Democratic Society, or Minbyun. Minbyun is a member of the coalition, along with People's Solidarity for Participatory Democracy. In a statement, the coalition said about 600 Korean youths are sent to jail every year for refusing to join the military, mostly motivated by religious convictions. "The issue of conscientious objectors should be raised as a social issue, not as an individual problem," the statement said. Minbyun said it sent a letter to the U.N. Commission on Human Rights last month, urging the international body to draw world attention to the issue of Korean conscientious objectors. In October last year, Amnesty International sent a delegation to Korea to discuss pressing human rights issues. In a statement, the international body urged the Seoul government to release all conscientious objectors, calling them "prisoners of conscience." Under Korean law, all male youths are required to perform military service for 26 months on average in the Army. Civilian forms of service are available only to those with health problems, while those with serious disabilities are excused. (sjkang@koreaherald.co.kr)

#### Conscientious objectors anticipate ruling by Constitutional Court

(Feb 16, 2002) Business owner Kim Woo-kon, 51, and his 49-year-old wife, Lee Chong-rye, general affairs manager of a translation company, visit their son every week at the Seoul Detention House. A 23-year-old college graduate who majored in international affairs, the junior Kim has been imprisoned for more than a year for refusing to serve in the military for religious reasons. Now they, like the families of more than 1,600 Koreans who are in prison for similar reasons, anticipate a Constitutional Court ruling, the promise of which they call "thrilling" because it raises hope of a victory for their cause. In late January, Senior Judge Park Si-hwan at the Nambu (Southern) Branch of the Seoul District Court decided to send

Section 88 of the Military Service Law to the Constitutional Court for review. The military conscription law, which normally requires a minimum of 26 months of service, makes no provisions for conscientious objectors - those who reject military service on the basis of their religious or ethical beliefs. The court action was taken in response to a petition by 21-year-old Lee Kyung-su, a conscientious objector who had spent 40 days in prison. Lee - like Kim Woo-kon, Lee Chong-rye and their son - is a Jehovah's Witness and refuses to serve on religious grounds. "I was surprised at the news that my petition to review the law was accepted," said Lee. "All of Korea was surprised, wasn't it?" Under Section 88, those who refuse the draft can face up to three years' imprisonment, although the trend in recent years has been toward sentences of 18 months, the minimum necessary for the person to avoid re-conscription. The district court judge said there is "a high possibility" that this section violates basic rights guaranteed under the Constitution, especially the right to freedom of conscience, thought and religion. "The duty of military service is the basic duty of Korean people under the Constitution, and is a sacred and important duty necessary for keeping the free and democratic basic order, which is the basic system of the Republic of Korea," the judge said in a statement. "On the other hand, the freedom of thought and conscience is also recognized as a core basic right which forms the basis of free and democratic order, and freedom of religion is also an important basic right, which is recognized by all free democratic states." Noting that many other countries recognize conscientious objectors as a special case under the law, the judge said it was time for Korea to consider doing the same. Human rights groups such as Amnesty International, People's Solidarity for Participatory Democracy, Lawyers for a Democratic Society (also known by its Korean name, Minbyun), Sarangbang and Solidarity for Peace and Human Rights favor the establishment of an alternative civilian service for conscientious objectors. Representatives of 30 civic groups, along with many individual supporters, recently joined forces to form Korea Solidarity for Conscientious Objection and held a rally in Seoul. Lee, who has been released on bail, did not attend, saying even protests and rallies violate the spirit of his religion. Until recently a fashion design student at Seokyung University in Seoul, he has interrupted his studies until the case is resolved, although he could have delayed his conscription to finish his education. His trial was suspended, pending a ruling by the Constitutional Court. "The matter is lingering in my mind and it keeps me from concentrating on my studies," Lee said.
