The Revision of the National Security Law (NSL)

In a coup-like manner, the ruling Democratic Liberal Party (DLP) pushed a »revision« of the NSL through the parliament on May 10, 1991. However, there was neither a discussion nor a plenary vote. The DLP spokesman read in parliament the draft of the revised law, surrounded by members of his own party, and disappeared then. He believed that his parliamentary duties were satisfied by this half-inute action. This procedure already shows the position of the ruling DLP to changing the NSL.

In his 8-point declaration of June 1987 then presidential candidate Roh had promised a thorough democratic renewal of South Korea. Parliament was to decide he respective legal amendments in the current parliamentary term. This applied particularly to the NSL, the Police Act, the Broadcasting Act, and the Act on the National Security Agency (Angibu). But the approved amendment of the NSL does hardly fulfill the promise of a thorough democratic renewal.

The changes in the NSL:

1. The old §2 states: "every group inside and outside the country aiming at taking over the government or destroy the political system of the state will be considered an enemy of the state". This is a reference to North Korea, but also to all organisations concerned about reunification or democratisation of South Korea. In the amended version there is the following phrase that is supposed to put it more precisely: "every group inside and outside the country whose structure shows leading committees and functions will be considered an enemy of the state".

Everybody knows that with such an amendment the government can even more than before arbitrarily persecute groups and organisation that were not yet covered by the old law.

- 2. In the old version it is stated »all activities are illegal that benefit the enemy«. The new version states more precisely »all activities are illegal that can be assumed to threaten the existence and security of the state or its liberal democratic constitution«. The new version just as the old allows every possible interpretation.
- 3. The new §10 of the NSL states "everybody acts illegally who does not inform police of his knowledge of the following criminal offences: founding of an enemy-benefiting organisation, activities that benefit enemy-benefiting organisations, voluntary support of enemy-benefiting organisations, attempts, preparations or conspiracies to found an enemy-benefiting organisation."

What is new is that relatives of persons that violate this §10 will no longer be persecuted.

4. §3 and §7 were eased in the new version. The following criminal offences relating to preparation of conspiracies or to conspiracies will no longer be persecuted: for instance advocating publicly enemy-benefiting organisations and sympathy with them, possession of literature hostile to the state, correspondence and contact with enemy-benefiting organisations. Previously every person could be punished already because of

reading or possessing socialist or communist literature. This will no longer be possible, according to the new §3. However, punishment of these activities will still be possible according to other paragraphs.

5. In the old version of the NSL §14 stated that everybody sentenced for violating the NSL will lose his or her civic rights for the time of their imprisonment. The new version has modified this clause somewhat to »some« prisoners keeping their civic rights while in jail. Who these persons will be and how that will be practised is left open. So this new version can still be completely arbitrarily interpreted.

It is obvious that the NSL has been changed only in a few subordinate points that in no way change the anti-democratic nature of this law. The individual phrasing in the various paragraphs remain very general and unclear and allow any interpretation.

Some of the prisoners that were jailed according to the NSL were released after this revision to create the public impression of democratic renewal. But it soon became clear that these were people that would soon have been released anyway or had received only light sentences.

If the South Korean government were really serious and would intend to start a democratic renewal there would have to be an amnesty for all prisoners that were jailed under the NSL. There could be a credible beginning with the release of Im Su Gyong and Moon Kyu Hyun.

The NSL can not be reformed, it can only be abolished.

With this law, the regime has

- * suppressed every democratic and opposition group and discriminated against its members
- * blocked every dialogue and discussion with or about North Korea within South Korea.
- * With the admission of both Korean states to the United Nations, this law will ultimately be anachronistic.
- * It is important that the South Korean government finally (including at home) recognizes the existence of the North Korean state that has dioplomatic relations to 140 other states.
- * With the UN membership of both the North and the South, South Korea has to give up its claim to represent all of Korea.
- * If all commitments to re-unification, declared solemnly in 1972 and 1987, are not to decay to rotten propaganda, mutual recognition with North Korea is the command of the hour.

However, all these steps are impossible under this NSL.

The European Ecumenical Network on Korea (EUKONET) is a group of staff members of Churches and various church-related organisations in Europe working on Korean issues. It was established in Hamburg in 1987 and has met several times since.

We are writing to you to express our concern about the serious violation of human rights within the Republic of Korea (South Korea). We urge you to bring this to the attention of the European Parliament and request you to pursue any action which might rectify this inhuman situation.

According to the National Council of Churches in Korea (NCCK), one of EUKONET's partners in Korea, "Statistics reveal the 6th Republic's immoral trampling of personal liberty, its suppression of the democratisation movement and its blocking of the reunification movement, mainly through the use of the National Security Law".

We refer particularly to the case of the Reverend Hong Keunsoo, a 54 year old pastor, who was sentenced to two years imprisonment in August 1991. He was accused, under the National Security Law, of praising North Korean Unification policy and meeting anit-state organisation members. He published a book in which he praised North Korea. The NCCK states that his arrest and prosecution "violates the people's freedom of study and thought."

KEEP operates under the general supervision of the Asia Committee of the Conference for World Mission of the Council of Churches for Britain and Ireland.

We feel that many of Korea's problems were created in the first place by outside interference. On its Liberation from Japan in 1945, the country was divided by the world powers and it seems that the influence of these powers still helps to make this a divided nation. The South Korean government still uses the National Security Law by which the Cold War psychology in favour of the division of the country is manifest. Outside powers bear a responsibility for what has interference.

EUKONET was represented at the meeting on the 11 September 1991, initiated by Minhyop (The Association for Democracy in Korea), when MEPs were asked to consider having a Hearing on the Human Rights situation in Korea in the European Parliament. At this meeting it was decided that a half-day sponsored by the Green Party:

3.00 pm - 6.30 pm on Thursday 13 February, in Strasbourg.

We would particularly urge you to attend this Hearing, and to act in accordance with any decisions taken for follow up action, to end this unjust situation in the Republic of Korea.

We would be glad to supply information from our Korean Church partners.

I now enclose a copy of a booklet EUKONET published on the background of the movement for Reunification.

We look forward to working with you on this important issue. Yours sincerely,

Patricia Hamilton Convenor of EUKONET a "funeral committee" to protest the death of Kang Kyung-dae and make arrangements for his funeral. Moon Ik-hwan was said to have been elected chairman of this committee. During the following weeks many protests and demonstrations were organized by the funeral committee and other student bodies to protest against the death. Some of the protests became violent and a number of students and workers committed self-immolation.

On 18 May 1991 state prosecutors once again warned Reverend Moon Ik-hwan that he faced possible reimprisonment. A state prosecution spokesman is reported to have said that there was no firm evidence to suggest that Reverend Moon Ik-hwan had broken the law in connection with his activities as chairperson of the funeral committee for Kang Kyung-dae, but added that a number of his recent speeches violated the National Security Law. On 6 June Reverend Moon Ik-hwan was rearrested on the grounds that he had violated the terms of his parole by engaging in political activities and that his health had improved.

Reverend Moon Ik-hwan is now serving the remainder of his seven year prison term. To Amnesty International's knowledge no new charges have been brought against him. The organization has readopted him as a prisoner of conscience and is calling for his immediate and unconditional release.

Reverend Moon Ik-hwan is a Presbyterian minister and an Old Testament scholar. He has written 10 books of poetry and essays and is a proponent of "Minjung (People's) Theology". He became involved in activities critical of the government in the mid-1970s and has previously been imprisoned from March 1976 to December 1977, from October 1978 to December 1979, from May 1980 to December 1982 and from May 1986 to July 1987.

1991 KOREA HUMAN RIGHTS SITUATION

1. Situation of Prisoners of Conscience in 1991

The Korean Government still denies the fact that there are many prisoners of conscience in Korea. But according to various reliable sources including our own research, 1140 prisoners of conscience were officially arrested and prosecuted in 1991, an average of 3.1 persons per day. This is two times the figure of 1.6 arrested per day under Chun Doo-Hwan's 5th Republic dictatorship. At present, there are 1103 prisoners of conscience in south They include 496 students, 334 workers, 85 opposition persons, 20 publishers, 40 soldiers and policemen, 7 farmers, 5 teachers and 96 long-term prisonersr, and 20 others. In July, 1991, the number of prisoners of conscience is the highest it has been since the beginning of the 5th Republic in 1980. But Roh Tae-Woo's government says, "We have no political prisoners."

According to the above figures, those imprisoned under the Anti-Firebomb Law and Law on Assembly and Demonstration are the largest in number next to those jailed under the National Security Law. This proves that the basic rights of the people, such as the freedom of assembly and demonstration, are severely blocked by the government. Students and workers comprise the largest categories of political prisoners.

2. Situation of Long-term Prisoners of Conscience

Anyone who has been sentenced to more than seven years' imprisonment is called a long-term prisoner. Most long-term prisoners have been in jail for 20-40 years, under conviction as spies. 52 long-term prisoners were released in 1989 in accordance with the abolition of the Social Security Law. This leaves, at present, 96 long-term prisoners still in jail.

On Nov. 21, 1991, Choi In-Jung, who had anxiously been looking forward to meeting with his family in north Korea, died of cancer. Choi was arrested in 1965 due to his espionage activities, and was released in 1988. Following his release he made a living as a laborer. But he suffered from illness caused by his long imprisonment, and moreover, he had no relatives to care for him. What he wanted above all else was to meet with his family in the north before he died, but his life ended without the realization of his dream.

On Nov. 19, 1991, NCCK opened the "House of Love" for released long-term prisoners. This will be a home for them; will enable their independent living; will help them recover their lost years to some extent; and will assist their readjustment to society.

The conception of "spy" in Korea is a product of the division of the nation; consequently, the "spy" is the victim of the division. Therefore, the human rights problem of long-term prisoners must be solved by overcoming the situation of national division, and ultimately by the reunification of Korea. Thus, working for the release and return to society of long-term prisoners is an important contribution to the reunification movement and to the improvement of human rights.

3. Violation of Prisoners' Human Rights

At present, there are more than 50,000 prisoners in Korean jails. But the facilities for them are quite insufficient and inferior, and their treatment is inhumane. An average cell holding 10 to 20 prisoners is 4-5 pyong (about 4 m × 4 m in area), which means that the space per person is only 0.2 to 0.4 pyong (1 sq. meter, more or less). The major cause of such overcrowding is the police's abuse of their detention and investigation functions.

As for medical treatment, a mere 54 doctors serve all 50,000 prisoners, and since these doctors are busy with their own hospitals, an average of 20 prisoners per year die due to a lack of medical care. Moreover, prisoners suffer every day from the violent treatment and language of the guards. But the facts about the trampling of human rights in the jails, isolated from society, are not known to most of the public.

In November 1991, farmers' movement member Hoh Yun-Ha was chained to the bars of his prison cell, with his arms up in the air and his feet barely touching the floor, and was beaten. He was kept in this situation for several days, and during this time was not allowed to eat regular meals. This incident brought shocked reactions from many citizens.

It is an international recognized convention that all prisoners, regardless of their criminal acts, must enjoy basic rights and dignity as human beings without any infringement by state power.

From September, NCCK has been raising funds for the provision of clothes, blankets, etc., for a warm winter for all Korean prisoners. The funds gathered up to mid-December were sent to many prisoners on Christmas day.

4. Question of Kang's Handwriting

Kang Ki-Hun, staffer of the National Alliance for Democratic Movement (Chonminyon), was sentenced in December to three years' imprisonment, charged with having forged the suicide note of Kim Ki-Sol, his fellow Chonminyon staffer who set himself afire and leaped to his death last May 8. Kang has consistently maintained his innocence. During many days of investigation by the prosection, he was deprived of sleep. The 17 lawyers who are defending him have criticized the prosection for trying Kang without having concrete evidence.

NCCK requested the assistance of Onishi Yoshio, Japan's top handwriting expert, who showed that Kang did not write Kim Ki-Sol's suicide note, and that Kim himself was the writer. Onishi examined six samples of Kim's handwriting, and according to his analysis, "Kim Ki-Sol's suicide note and Kang Ki-Hun's handwriting are fundamentally different." This was in sharp contrast to the investigation carried out by Korea's National Institute of Scientific Investigation. The Korean prosecution immediately rejected Onishi's analysis, saying, "It's meaningless since it was done by a foreigner."

5. Kang Kyong-Dae Incident

A twisted justice system let off lightly the five riot policemen who beat student Kang Kyong-Dae to death last April 24, and has punished Kang's father, Kang Min-Jo (age 49) for contempt of court. Furthermore, when Kang's mother protested the arrest of her husband, she was hit with clubs by riot police and had three of her front teeth broken. She reportedly suffers from health problems following the shock of her son's death.

At the first court hearing for the five policemen charged with the killing, their defense lawyer asked one defendant, "Is it correct that Kang Kyong-Dae was about to throw a firebomb when you hit him?" and the policeman said, "That's right." This touched off a big commotion by Kang's family members and others, and resulted in the prosection of Kang's father for contempt of court. South Korean courts are notorious for their pro-government decisions in most political cases.

On Dec. 5, NCCK presented its 1991 Human Rights Award to Kang's family, in token of their struggle for the democratization of Korea. Kang's mother accepted the award. She said, "I keep expecting to hear his voice, keep expecting to see him walk in the door...Recently I started going to church; this was my son's wish, and it gives me comfort."

Reverend Moon Ik-hwan, a 73-year-old Presbyterian minister, is serving a seven year prison term for his non-violent political activities. Reverend Moon Ik-hwan was arrested in April 1989 for making an unauthorized visit to North Korea. He was released on parole in October 1990 on grounds of ill-health but was rearrested in June 1991 for violating the terms of his parole by taking part in political activities. Amnesty International considers that the mere fact of travelling to North Korea without evidence either of espionage activities or the use or advocacy of violence cannot justify imprisonment. It considers Reverend Moon Ik-hwan to be a prisoner of conscience, held for his peaceful political activities. It is calling for his immediate and unconditional release.

Reverend Moon Ik-hwan and Yu Won-ho, a 69-year-old businessman, visited North Korea from 25 March to 3 April 1989. Reverend Moon Ik-hwan was the first person to take up an invitation from President Kim Il-sung, the North Korean leader, extended in his New Year message to seven South Korean public figures to visit the North Korean capital Pyongyang to discuss reunification. In North Korea Reverend Moon Ik-hwan had several meetings with government officials and reportedly held discussions with Kim Ilsung for seven hours. He issued a joint statement with Ho Dam, then Chairman of the North Korean Committee on Reunification of the Fatherland, on the basic principles that should govern Korean reunification. He also attended church services and visited some of his relatives. Reverend Moon Ik-hwan said that he hoped his visit would give a fresh impetus to dialogue between the North and the South and would open the way for contacts between non-government people.

Reverend Moon Ik-hwan and Yu Won-ho were arrested on 13 April 1989 at Seoul's Kimpo International Airport as they returned to South Korea. Both men were charged under the National Security Law. Reverend Moon Ik-hwan was charged under Article 6(2) with "escaping to an enemy area under enemy instructions", under Article 7(1) with praising North Korea and under Article 8(1) with meeting and communicating with the enemy. Yu Won-ho was charged with organizing Reverend Moon Ik-hwan's visit to North Korea and accepting money from a pro-North Korean group in Japan. On 5 October 1989 both men were sentenced to 10 years' imprisonment. The presiding judge acquitted them on the charge of praising and sympathizing with North Korean leaders. He accepted that their visit had been motivated by their commitment to reunification of the country but said that they had fallen victims to a North Korean propaganda ploy and in so doing had harmed the interests of the South. Reverend Moon Ik-hwan and Yu Won-ho's prison sentences were reduced to seven years' imprisonment at a High Court appeal hearing in February 1990.

During 1989 four other people were arrested for making unauthorized visits to North Korea. Suh Kyung-won, an opposition member of the National Assembly, and his secretary Pang Yang-kyun were arrested in June and July 1989 for an illegal visit made by Suh Kyung-won in 1988. Ms Im Su-kyong and Father Moon Kyu-hyun were arrested in August 1989 as they crossed from North to South Korea at the armistice village of Panmunjom. Im Su-kyong, a student, had taken part in the July 1989 World Festival of Youth and Students, held in Pyongyang. These four prisoners have been adopted by Amnesty International as prisoners of conscience.

On 20 October 1990 Reverend Moon Ik-hwan's prison sentence was suspended and he was released from prison. The authorities said that he had been released because of his recent ill-health (he had been suffering form heart disease and hypertension) and on account of his old age.

Since his release, Reverend Moon Ik-hwan is reported to have delivered speeches at at least 100 meetings of students and dissidents and to have participated in other political activities. State prosecutors are reported to have warned Reverend Moon Ik-hwan on several occasions that he might be reimprisoned if he did not curtail his activities. In late December 1990 the Seoul Pukpu district police are reported to have warned him to stop speaking to gatherings of students and dissidents about his visit to North Korea and about North Korean ideology. In late January 1991 he was placed under house arrest to prevent him from attending the inauguration meeting for the preparatory committee of the South Korean headquarters of *Pomminnyon* (Pan-National Alliance for Reunification of Korea). He later became chairperson of the preparatory committee. The South Korean authorities regard *Pomminnyon* as an anti-state organization and many of its leaders have been arrested (see *South Korea: Update on Pomminnyon Arrests, ASA 25/29/91*).

On 26 April 1991 student Kang Kyung-dae was beaten to death by riot police during an anti-government demonstration. His death provoked violent demonstrations throughout South Korea by students, workers and dissident groups and led to the arrests of five riot policemen on charges of murder. Students and dissident leaders established

Human Rights Violations: Case Studies

Violation of the Freedom of Speech of Scientists

Case 1: On July 11, 1990 the scientific assistants of of AALARI (Africa, Asia and Latin America Research Institute), Kim Myung-Sik (simultaneously executive committee member of Chunminryun for international affairs), Bu Chwa-Hyun, Lee Jae-Ho and the director of the "Sonamu« publishing company, Yoo Chae-Hyun, were arrested. According to the prosecutor, they are indicted for violating the NSL. They had published a book that collaborates with the enemy. The book deals with the uprising in Cheju island of April 3, 1948 and had heen published already three years ago. At the time of his arrest, Kim Myung-Sik was in the preparatory commission of the Pan-National Demonstration on August 15. He was arrested to obstruct this event.

Case 2: On June 27 the scientific assistants of the Seoul Social Sciences Institute Lee Chang-Hee and Song Ju-Myung were arrested together with the former assistants Han Jun, Hong Sung-Tae and Shin Hyun-Jun. They were at that time serving in the military. According to the prosecutor, they were arrested because they spread socialist ideas beyond their scientific area. The theme of their work was: New Research on the Socialist Political Economy of the 1960's and early 1970's.

Case 3: Early 1989 the editor's office of the progressive daily newspaper Hankyoreh Shinmun was searched by the prosecutor. A reporter was arrested because he had interviewed Seo Kyung-Won, who had later visited North Korea. At the same time, journalist Prof. Lee Song-Hee was arrested because he intended to write about North Korea. The prosecutor warned the reporter that he had violated the NSL by not notifying the police. The prosecutor confiscated the articles.

These examples show the typical violation of the freedom of opinion, of the press and of science and are a violation of the United Nations Charter on Human Rights.

Surveillance and >Black Lists«

Case 4: On October 1, 1990 the soldier Yoon Sok-Yang serving in the Military Security Command distributed a »black list«. It namend private citizens, opposition activists, student representatives and leaders of opposition parties. You could read for example what writer Yoon Jung-Mo had talked with a taxidriver. The violation of privacy and the surveillance of the people are obvious.

After the *black list« became public, the Ministry of the Interior accepted responsibility (some resignations) and the military was supposed to end this surveillance. However, the MSC was merely renamed Military Disciplinary Service.

The incidents at the Seoul Social Sciences Institute (case 2) and the investigations of the prosecutor against the Seogang students' representatives indicated, however, the continued existence of

»black lists«. Job search is obstructed by such lists and they are a violation of human rights.

Case 5: On Ecptember 17, 1991 in a snoe factory in Pusan another *black list« with 8000 names was discovered. On the list were not only names of dismissed workers, but also Noh Mu-Hyun MP and opposition leader Kim Hec-Tak who was already arrested. In the list there was a detailed profile of the personality, ID numbers, addresses, personal education, curriculum vitae etc. This content indicates that the company hardly could have compiled the list. The government denied any collaboration.

Korean Dreyfus Case

Case 6: On May 6, 1991 a student was clubbed to death by the police, causing public anger. Eight suicides by burning followed. In this situation Kang Ki-Hun (deputy president of Chunminryun) was arrested. According to police reports, Kang had written a testament and forced Kim Ki-Seol to burn himself.

This case, called *Korean Dreyfus case*, shows that the government tries to blame the opposition for public unrest. Instead of looking at the real reasons they label opposition activists as wire-pullers. Despite evidence to the contrary, Kang was sentenced to 3 years in jail.

Unclear Death Cases

Case 7:

- In May 1989, student Lee Chul-Kyu from Choson University was found daed at a lake, while he was officially wanted by the police for an article. Despite traces of handcuffs the police stated he died of stumbling.
- In August 1989 student representative Lee Nae-Chang from Chungang University was found dead at the south coast. Despite information that he was seen accompanied by an agent of state security, the police stated death by drowning.
- On May 6, 1991 the president of Han-Jin Heavy Industries trade union, Park Chang-Soo was killed. He had been jailed since February for his trade union activities. The police confiscated the corpse and ordered without the family's permission an obduction. They reported about a deadly fall, despite later in the hospital no evidence was found for that.

There are more unclear death cases in recent times, so that the relatives have formed an organisation to clarify these detahs and to sue the responsible persons. The police always ordered immediate cremation of the corpses. Dead persons reported mostly as missing or suicides now are increasingly members of the army. Some students that were politically active in the university were forced in the army to give informations and to give up their beliefs. There is evidence that deaths occurred in such situations. This is another reason why declarations of conscience, calls for democratisation, withdrawal of U.S. troops, separation

of police and army and ending the brutalities in the army are increasing.

Accusations of Organisations as Enemy of the State

Case 8: The basic right of freedom of association is restricted by declarations as *enemy of the state«. So far are affected:

- Inchun Buchun Workers Group
- Evangelical Cultural Movement
- Anyang Democratic Workers Group
- *Working Class«
- Revolutionary Workers Association
- Workers Association for Reunification and Democracy
- Workers Association in the Northern District (Seoul)
- Workors Croup Inchen
- Socialist Workers Association (Sanomeng)
- Democratic Trade Union Group
- Group for Sovereignty, Democracy and Reunification
- National Students Association
- Anti-Imperialist and Anti-Fascist Popular Democratic Group etc.

Since February 1988 more than 10 organisations were classified by the police as *collaborating with the enemy* (violation of the NSL). Among them are non-existent organisations. In some cases it was later confirmed that they were invented during torture.

Freedom of association does not mean the free possibility of forming pro-government groups, but particularly freedom of opposition groups.

For poet Park Noh-Hae, a member of the central committee of Sanomeng, in the first and second trial the death penalty was demanded: another example of the violation of the freedom of association and opinion.

Heavy Penalties for Reunification Activists

Case 9: Since the visits to North Korea by Rev. Moon Ik-Hwan in March 1989 and by student representative Im Su-Kyung in July/August 1989 for the World Youth Festival, they are considered leaders of the reunification movement and arrested in South Korea. Rev. Moon was sentenced to 7 years and Im Su-Kyung to 5 years in jail: an anachronistic violation of human rights. Further, three representatives of the non-official South Korean section of the Pan-Korean Alliance were arrested and convicted in November 1990 after meeting North Koreans in Berlin.

Since the end of the last year there is a permanent conference between North and South Korea on prime minister's level. Even after the North-South accords these people are still jailed.
